



NOTICE of RACE

BCYC Women's SKIPPERS REGATTA BAY CITY YACHT CLUB June 14th, 2008

Bay City Yacht Club is sponsoring a Women's Skippers Regatta on June 14th, 2008. The event will be for PHRF main & jib and spinnaker fleets for both monohull and multihull boats. All registered boats must be skippered by women from the end of postponement until finishing. The regatta will consist of 2 races.

Eligibility

This event is open to BCYC members as well as area sailors.

The race is open to any monohull yacht over nineteen (19) feet in length or any multihull yacht twenty-three (23) feet or over in length or with a speed potential of 700 Portsmouth or lower. Entries will be split into classes with the approximate size of each class to be eight (8) boats. Class splits will be determined by PHRF rating.

Rules

Racing will be conducted in accordance with the following:

- a) The 2005-2008 ISF Racing Rules of Sailing (RRS) and the prescriptions of US SAILING;
- b) The Notice of Race and any amendments thereto;
- c) The Sailing Instructions and any amendments thereto.
- d) All participating boats will be skippered by women

Entry

To enter the race, complete the attached Application and Waiver Form and submit it with the appropriate entry fee to the race chair, Greg Horvath (see address on the bottom of the form). The cost of this event is \$25.00 (\$30.00 for non-US Sailing members). **Entries will be accepted through June 10th, 2008.**
